

Marshall Road State School iLearn Student Participation Agreement Year 4 to 6 (Shared Device)



General Use

- 1. I understand that the iPad remains at school and is shared with other students across my year level. I will ensure that I have logged out of all programs after use within my classroom.
- 2. I will ensure the iPad is charged in the classroom and ready to use at the beginning of each school day. The iPad charger does not go home.
- 3. I will hold the iPad carefully when carrying it and will walk with it at all times.
- 4. I will follow all staff directions in relation to the use of my iPad, including connecting my iPad to Apple Classroom app.
- **5.** I will only take photos and record sound and video when granted permission by my teacher.
- 6. I will not access other students' iPads
- 7. I will keep food and drinks away from the iPad.
- 8. If the classroom teacher is absent, and not replaced by a MRSS staff member, the iPad will not be used for the day.
- **9.** I will immediately report any accidents or breakages to my parents and teachers.
- 10. If the iPad is damaged at school, I understand the school will investigate to determine the cause of the damage and the MRSS Student Code of Conduct will be followed. If damage is caused by deliberate or careless actions of a student, the costs of repair will be passed onto those involved and necessary behaviour consequences may apply. The decision around the responsibility for repair costs is at the discretion of the Principal.

Content

- 1. I will use the iPad only to support my school learning program.
- 2. I understand that my teachers will monitor my use of the iPad and check the websites that I visit.
- **3.** I understand there will be consequences for inappropriate use and behaviour consequences may apply, including but not limited to, loss of privilege of using the iPad for a period of time.

Safety and Security

- 1. I will only connect the iPad to the DET's filtered internet service and Education Queensland's Managed Internet Service (MIS).
- 2. I will only go to websites at school that support my learning activities. I understand that website use is monitored through the DET's filtered internet service.
- 3. I will only use my school email account for mail related to my learning and under direction of my teacher.
- **4.** I will not send group emails or chain emails from my school email account.
- 5. I will be cybersafe and cybersmart. I will use etiquette and respect when using my iPad with regard to people.
- **6.** The school name, logo or uniform must not be used in any way that would result in a negative impact for the school and its community. I will not post photos, audio or video of such online.
- 7. I will use my iPad lawfully and in accordance with the Student Code of Conduct for Marshall Road State School.
- **8.** For security reasons, I am not to share account names and passwords with anyone unless requested by Marshall Road State School staff when servicing the iPad.

I agree to abide by the guidelines outlined in the iLearn Student Participation Agreement – Year 4 to 6 (Shared iPad). I also commit to being a responsible user of technology. I understand that non-compliance or irresponsible behaviour consequences relative to the behaviour will be determine by the school as per the MRSS Student Code of Conduct.
