iLearn Student Participation Agreement Year 4 to 6



General Use

- 1. It is my responsibility to keep my iPad, keyboard, headphones and optional stylus charged and in good working condition.
- 2. It is my responsibility to bring my iPad, inside its protective case, to school each day.
- 3. I will ensure my iPad is charged and ready to use at the beginning of each school day. I will leave the iPad charger at home.
- **4.** I will hold the iPad carefully when carrying it and will walk with it at all times.
- 5. I will ensure my iPad is kept in my school bag when travelling to/from school. I will not use it prior to 8:50am or after 3:00pm.
- 6. I will follow all staff directions in relation to the use of my iPad, including connecting my iPad to Apple Classroom app.
- 7. I will only take photos and record sound and video when granted permission by my teacher.
- 8. I will not access other students' iPads.
- 9. I understand that my iPad remains at school during excursions and interschool sport.
- 10. If the classroom teacher is absent, and not replaced by a MRSS staff member, the iPad will not be used for the day.
- 11. I will immediately report any accidents or breakages to my parents and teachers.
- 12. If my iPad is damaged at school, I understand the school will investigate to determine the cause of the damage and the MRSS Student Code of Conduct will be followed. If damage is caused by deliberate or careless actions of a student (owner or others), the costs of repair will be passed onto those involved and necessary behaviour consequences may apply. The decision around the responsibility for repair costs is at the discretion of the Principal.

Content

- 1. I will use my iPad only to support my school learning program whilst at Marshall Road State School.
- 2. I understand that my parents will purchase and install my Core apps and Year Level apps and regularly update apps.
- 3. I will have a 'Focus' configuration set up on my iPad for school and home use. I will put all non-school apps in a folder called Home. I will not use these apps at school.
- 4. I will not use iMessage during school hours or whilst on school grounds. It will be turned off in settings during the school day.
- 5. I understand that use of iMessage at home is at my parents'/guardians' discretion and will be supervised by my parents/guardians. At no stage will any iMessage groups be set up, or participated in, that use class or school names.
- **6.** I will not install inappropriate apps or content on my iPad (i.e. Facebook, Facebook Messenger, Snapchat, Instagram, TikTok, Kik, Monkey, Fortnite, Discord or any other social media sites that require users to be over 13 years of age).
- 7. I am responsible to ensure my iPad is backed up and is running the current iPadOS.
- 8. I will ensure there is adequate free storage available on my device for classroom use.
- 9. I permit my teachers and parents to perform checks to monitor that I have not installed unsuitable software or content.
- **10.** I understand there will be consequences for inappropriate use and behaviour consequences may apply, including but not limited to, loss of privilege of using the iPad for a period of time.

Safety and Security

- 1. While I am at school, I will only connect my iPad to the DET's filtered internet service and Education Queensland's Managed Internet Service (MIS).
- 2. While I am at school, I will only go to websites at school that support my learning activities. I understand that website use is monitored through the DET's filtered internet service.
- 3. I will only use my school email account for mail related to my learning and under direction of my teacher.
- **4.** I will not send group emails or chain emails from my school email account.
- 5. I will be cybersafe and cybersmart. I will use etiquette and respect when using my iPad with regard to people.
- **6.** I will not share names, personal details or images of myself or others, online or in electronic communication.
- 7. The school name, logo or uniform must not be used in any way that would result in a negative impact for the school and its community. I will not post photos, audio or video of such online.
- **8.** I will use my iPad lawfully and in accordance with the Student Code of Conduct for Marshall Road State School.
- **9.** For security reasons, I am not to share account names and passwords with anyone unless requested by Marshall Road State School staff when servicing the iPad.
- 10. I am responsible for the security and use of my iPad while at Marshall Road State School.

I agree to abide by the guidelines outlined in the iLearn Student Participation Agreement - Year 4 to 6. I also commit to being a responsible user of technology. I understand that non-compliance or irresponsible behaviour consequences relative to the behaviour will be determine by the school as per the MRSS Student Code of Conduct.
